FRANCHISE AGREEMENT

This Franchise Agreement is made on this 6th day of May, 2026.

BETWEEN

RideinGo Private Limited, a company incorporated under the laws of India,
having its registered office at: Dumuria Part - III, P.O. – Piradhara, P.S. – Abhayapuri,
District – Bongaigaon, State – Assam, PIN – 783384 (hereinafter referred to as the “Franchisor.”)
AND

Mr./Ms.

(hereinafter referred to as the “Franchisee”.)

Both the party agreed to the following terms and conditions:

1. **BUSINESS RIGHTS:** Franchisor grants to the Franchisee for right to operate RideinGo transport services (Cab, BikeTaxi, Goods Carrier, Ambulance) in the stipulated territory area:(Assam).
2. **Business terms and time period:** This agreement shall be valid for a specific time period, which may depend on the interest of the franchisee; and If the franchisee will not be continue business with the franchisor for at least three months then the franchisor may be issued three months prior notice to the franchisee and the franchisee must continue business otherwise this agreement will be automatically terminated after completion the notice period. The franchisor may not be issued Double ID of RideinGo in the same district in same time.

3. **Franchise Fee:** The Franchisee agrees to pay a one - time Franchise Fee of ₹1,10,000/- (Rupees One Lakh Ten Thousand Only) to the Franchisor. In the event that the Franchisee, for any reason whatsoever, decides not to continue the franchise business and wishes to terminate the franchise arrangement, the Franchisor shall refund 70% (Seventy Percent) of the Franchise Fee paid by the Franchisee after the completion of three (3) years from the date of this Agreement. The remaining 30% (Thirty Percent) of the Franchise Fee shall be retained by the Franchisor towards administrative, training, management, and other related expenses, and the Franchisee shall have no claim over such amount.

4. **REVENUE & COMMISSION-**Franchisee will get services under RideinGo brand and Franchisor agrees to pay 50% commission on per ride to Franchisee and Payment shall be get daily/weekly /monthly in the official working day.

5. **Bannering, Postering and Promotional Expenses Clause** The expenses incurred for bannering, postering, flex boards, hoardings, leaflets, and other marketing and promotional activities for the promotion of the RideinGo franchise business shall be shared between the parties as follows. 80% (Eighty Percent) of the total promotional expenses shall be borne by the “Franchisee” 20% (Twenty Percent) of the total promotional expenses shall be borne by the “Franchisor”. All promotional and advertising materials shall be designed, displayed, and distributed in accordance with the branding guidelines, standards, and prior approval of “RideinGo”

6. **GST Sharing Clause:** The applicable Goods and Services Tax (GST) arising from the operations of the RideinGo franchise shall be shared between the parties as follows: 50% (Fifty Percent) of the total GST liability shall be borne and paid by the “Franchisee”. 50% (Fifty Percent)* of the total GST liability shall be borne and paid by the “Franchisor”. The Franchisee shall ensure timely payment of its share of GST and provide all necessary records, invoices, and documents required for GST compliance and reporting. Both parties shall cooperate to comply with all applicable GST laws and regulations.

7. **RESPONSIBILITIES OF FRANCHISEE:-** The franchisee must be managed local driver with valid driving licence and appropriate fitness documents of the vehicles uses in the RideinGo business. Before giving permission to drive vehicle under RideinGo must ensure valid documents like (DL, RC, and Insurance of the vehicles). The driver must follow all local transport rules and regulations to be maintained dignity of the RideinGo brand image.

8. **RESPONSIBILITIES OF FRANCHISOR:** Provide brand name “RideinGo” may use with full rights; Provide basic guidance & support of the RideinGo Business; Provide guidance in the operational model/system/ program.

9. **Restriction on use RideinGo Brand :** Franchisee will not be misused the brand name or create duplicate Trademark or may not be inter into any sub let agreement without written permission of the franchisor.

10. **AREA RIGHTS:** Franchisee will get rights to continue business in the specific district of and may not be appointed any another Franchisee/ sub-franchise in any places.

11. **RideinGo Business agreement termination :** This agreement may be terminated on the following conditions: (a) On the violation of the terms and conditions of this agreement. (b) Found engage with Illegal activity. (c) Default on calculation, Audit and payment. d) Failure to be complies with the TRANSPORT laws. (Franchisee must comply with all government rules and regulations prescribed by the transport department)

12. **LIABILITY :** Franchisor shall not be responsible / liable for any unfortunate vehicle accidents, legal issue, or damages caused by Franchisee operations.

13. **DISPUTE RESOLUTION :** Any disputes will be resolved through courts in jurisdiction in accordance of the law procedures.

14. In case of death of FRANCHISOR, his legal heirs (spouse or children) or regal representatives may transfer it to its/his/her name as per this agreement with the RideinGo Franchisor.

How to Add a Franchise in RideInGo

1. The applicant shall submit a Franchise Application Form along with the required documents.
2. The applicant shall pay the prescribed Franchise Fee as determined by RideInGo.
3. RideInGo will verify the applicant's details, documents, and eligibility criteria.
4. Upon successful verification, a Franchise Agreement shall be executed between RideInGo and the Franchisee.
5. The Franchisee will receive access to the RideInGo franchise portal, operational guidelines, and training materials.
6. The Franchisee shall appoint drivers, onboard vehicles, and manage operations within the allotted territory in accordance with RideInGo policies.
7. After completion of the onboarding process and activation by RideInGo, the Franchisee will be authorized to operate under the RideInGo brand and provide services within the assigned area.



Note: The grant and activation of a RideInGo franchise will be subject to compliance with all applicable RideInGo terms and conditions, policies, operational guidelines, and other requirements as determined by the Company from time to time.

N.B: The Company reserves the right to approve, reject, suspend or terminate any franchise application if the franchisee fails to meet the Company's eligibility requirements, operational standards or contractual obligations.
